ANXIETY

When:January 27, 2023

Presenter: Nitoya Roberts, M.A., LPC-S

Description:

According Mental Health America, "Anxiety disorders are among the most common mental illness in America, there is around '42.5 Adults in the US with Anxiety Disorder." INC, M. H. A. (2022). <u>https://mhanational.org/mentalhealthfacts</u>. Retrieved November 6, 2022. The objective of this training is to take a closer look at Anxiety and Anxiety Related Disorders and why it is the most commonly diagnosed mental illness amongst Americans. Participants will learn to identify and treat Anxiety/Related Disorders based on a Holistic Approach and Cognitive Behavioral Therapy (CBT). Participants will learn to assist clients from the Holistic perspective as it relates to understanding the Cognitive Triangle and the relationship between one's emotional and physical health. During the training, participants will be introduced to, Todd Pressman's approach to understanding and treating Anxiety Disorders. Participants will also understand how to identify one's "Core fear and Chief Defenses" based on the Deconstructing Anxiety Model. By the end of the course, participants will have several treatment modalities to add to their tool boxes as they work to treat clients diagnosed with Anxiety/related Disorders.

- 1. Identify and diagnose Anxiety and related disorders
- 2. Learn to treat clients from the Holistic Approach
- 3. Identify one's "Core fear and Chief Defenses"

PRACTICAL TOOLS FOR TREATING TRAUMA

When: February 24, 2023

Presenter: Barbara Melton, M.Ed., LPC, LAC, NCC, MAC, CS

Description:

This workshop will begin by focusing on defining trauma and examining the section of the DSM-5 on Trauma and Stress-Related Disorders, with some attention to differential diagnosis and the different criterion for diagnosing children vs. adults with PTSD. Assessment instruments which are in public domain will also be provided. We will discuss prevalence and etiology and practical evidence-based methods for treating trauma, including in crisis situations. We will discuss strategies such as anchoring/grounding techniques, systematic desensitization, The Counting Method, demystification and identification of triggers, guided imagery, relaxation training, cognitive restructuring in dreamwork, cognitive behavior therapy, and interoceptive exercises. We will also cover how to offer trauma-informed care in a clinical atmosphere and how to tailor treatment modalities to different populations with an emphasis on crisis management/crisis situations, rape victims, military and their families, accident victims, survivors of childhood physical/sexual abuse, and disaster victims.

- 1. Diagnose Trauma and Stress-Related Disorders using DSM-5 criterion and assessment instruments.
- Identify incidence, prevalence, and etiology for Trauma and Stress-Related Disorders.
- Define Eye Movement Desensitization & Reprocessing (EMDR), Thought Field Therapy (TFT), Traumatic Incident Reduction (TIR), and Colin Ross' Trauma Model.
- 4. Define and describe 4 strategies for treatment.
- 5. Develop a tailored treatment modality for specific populations.

ADVANCED GROUP COUNSELING

Description:

This training is scheduled to take place in person. The location is 208 Blacks Drive, Greenville, SC 29615. See training website for updated information.

Groups can often be full of complexities and challenges. This training will provide participants an overview of various potential group dynamics, and potential challenges that could arise across these groups. This training will provide techniques that can be used to address these potential challenges and ways to implement and utilize these techniques. This training will also serve as a space for clinicians to discuss various experiences they have had overcoming these challenges.

- 1. Identify various group dynamics that can be present and potential challenges across these groups.
- 2. Gain insight into helpful techniques and interventions to utilize when presented with these group challenges.
- 3. Discuss and brainstorm with fellow clinicians around past experiences with group challenges and ways to learn from previous experiences.

GAME PLAN: A CLINICIANS GUIDE TO HELPING MEN ACHIEVE EMOTIONAL FITNESS

When: April 28, 2023

Presenter: Alan Lyme, LISW, CS

Description:

This is an interactive training for anyone who works with and would like to have a better understanding of men and how to help them. Participants will be challenged to examine assumptions and societal roles in male risk and recurrence factors, through media use, story-telling, and written exercises. Anger, intimacy, trust and relationship issues, and the efficacy of integrative and alternative therapies will be explored.

- 1. Describe the societal biases and "environment of risk" affecting males in resiliency, addiction onset, reoccurrence and recovery.
- 2. Underline the efficacy of a compassionate approach in working with men.
- 3. Demonstrate the dynamics and relate the value of integrative and alternative therapies with men.
- 4. Name two current treatment materials effective in men's work.

ETHICS

 When:
 May 26, 2023

Presenter: Alan Lyme, LISW, CS

Description:

The substance abuse and behavioral health field are fraught with ethical dilemmas. Lines are often blurred between legal, ethical, and moral influences as we make in-themoment decisions that can ripple out to create major unforeseen effect. This six-hour training will focus on some of the most common ethical digressions, reinforcing the importance of adhering to agreed-upon standards and the responsibility of maintaining competence. Individuals will be encouraged to bring their most challenging dilemmas to the conversation (de-identified) for group problem solving through several decisionmaking models.

- 1. Describe the core concepts of ethics in the substance abuse and behavioral health fields.
- 2. Explain the limits of confidentiality, when it should and should not be broken.
- 3. Describe the challenges posed by dual relationships, including the use of social digital media, and how to safely navigate them.
- 4. Identify three ethical decision making models.
- 5. Describe their own strengths and limitations in ethical dilemmas.

ADVANCED SUPERVISION SKILLS: SUPERVISION MODELS, EXPLORING THE "SELF" OF THE THERAPIST AND CONSIDERATIONS WHEN MANAGING DUAL ROLES AS A SUPERVISOR

ASAM

 When:
 July 28, 2023

Presenter: Jeff R. Brooks DMIN, LAC

Description:

A practical training designed to help counselors, social workers, administrators, and other clinical staff develop patient-centered service plans and make objective decisions about patient admission, continuing care, and transfer/discharge for individuals with addictive, substance-related, and co-occurring conditions. The course content is based on information found in the textbook: The ASAM Criteria: Treatment Criteria for Addictive, Substance-Related, and Co-Occurring Conditions, Third Edition, and provides opportunities for participants to practice applying the information through case-based activities. Participants will participate in a didactic\interactive lecture, small group discussion, case studies and application of the ASAM patient placement, decision flow process.

- 1. Describe the underlying principles and concepts of the ASAM Criteria.
- 2. Identify the six dimensions of the ASAM Criteria's multidimensional patient assessment.
- 3. Determine treatment priorities based on risk assessment to guide treatment and service planning.
- 4. Determine an appropriate level of care and treatment priorities based on risk assessment:
 - a. Demonstrate understanding of the ASAM Levels of Care and key treatment and organizational elements that distinguish each level.
 - b. Demonstrate ability to apply the ASAM Criteria in practice.

THE BRAIN AS AN OBSTACLE TO RECOVERY AND MAT PARTICIPATION/CO-OCCURRING DISORDERS

Description:

In this training, we will be discussing the neurological shortcomings we must face when helping people with addiction stabilize and recover. We will also learn how to recognize the difference between acute and chronic neurological changes. We will also be discussing Co-occurring disorders and their effects on counseling and treatment.

- 2. Discuss dealing with denial
- 3. Discuss and recognize neuro-complications
- 4. Describe how Co-occurring disorders affect counseling and treatment

BEST PRACTICES: APPLICATION OF LGBTQ+ AFFERMATIVE THERAPY

When: September 22, 2023

Presenter: Elizabeth (Liz) Serricchio, MA, LPCS, LPC, LAC

Description: ***This training is scheduled to take place in person. The location is 30 Pointe Cir, Greenville, SC 29615. See training website for updated information.***

This course will provide its participants with an overview of terms and definitions for shared language and a foundational knowledge base for working with this population. Participants will move from cultural competence to cultural humility by taking their foundational knowledge and learning how to apply it as an affirming provider. You will walk through the assessment, treatment planning, and a variety of case studies regarding typical scenarios you may encounter working with this population. These activities will serve as a practical application skills building process to identify affirmative protocols, techniques, and perspectives to increase clinical judgement and confidence in working with this population. Queer specific aspect of life, including the impact of public policy, will also be reviewed to increase your awareness of culturally sensitive differences to be aware of when treating a member of this community.

- To develop a sense of cultural competence through condensing foundational terms/definitions, local statics, and public policies impacting this marginalized population.
- To move forward into cultural humility by deconstructing the influence of social constructs and societal norms on the clinician in their practice with LGBTQ+ clients.
- 1. To gain practical application skills in terms of assessing, treatment planning, and providing affirmative care in the therapeutic relationship.

DIAGNOSIS OF SUBSTANCE USE DISORDERS

When: October 27, 2023

Presenter: Charissa Wolford, LISW-CP, LAC, CS, MAC

Description:

This training is scheduled to take place in person. The location is 208 Blacks Drive, Greenville, SC 29615. See training website for updated information.

Diagnosis of Substance Use Disorders can be complex. This training will provide participants an overview of the basics of developing substance use disorder diagnoses. This training will provide a review of DSM 5 criteria required to meet certain diagnoses, information on criteria justification and how to obtain this, and translating old diagnoses from DSM 4. This training will also assist clinicians in developing ways to obtain criteria information and how to document this.

- 1. Identify DSM 5 requirements for various SUD diagnoses.
- 2. Demonstrate insight into helpful techniques to obtain criteria justification.
- 3. Discuss ways to appropriately document diagnosis of substance use disorders.

WORLDS APART: WHAT WORKS IN ADOLESCENT TREATMENT AND WHY

When: November 17, 2023

Presenter: James Campbell, LPC, LAC, MAC, AADC

Description:

Sometimes adolescents can seem as though they come from an entirely different world, and in some regards they do! There has been a wealth of recent discoveries about adolescent development and learning. Unfortunately, there is frequently a disconnect between what we know works best with adolescents and the treatment modalities we use when working with them. This session reviews recent research and discoveries and explores how to best apply that knowledge to effectively treat adolescents with a strong emphasis on practical application.

- 1. Identify the fundamental developmental task of adolescence, why knowing this task matters, and how to leverage it effectively in prevention, intervention, and treatment.
- 2. Verbalize the vulnerabilities particular to adolescent development related to substance use.
- Articulate an understanding of the role of family, support systems, and traditional and social media in adolescence and how to help build support for the adolescents we serve.
- 4. Experience techniques designed to enhance engagement with adolescents.

ADDICTION 101

When: December 15, 2023

Presenter: Charlie Stinson, LAC, MAC, CCS, CPS

Description:

This training is scheduled to take place in person. The location is 208 Blacks Drive Greenville, SC 29615. The BHSA Region 1 Annual Awards Ceremony will take place during the lunch break. Lunch will be provided. See training website for updated information.

Working in the field of addiction treatment can feel daunting. What types of drugs are there? How do they affect a person? What is the difference between a depressant and a stimulant? What is tolerance and withdrawal? What does treatment look like? Does everyone need a Detoxification? Do we even call it Detoxification anymore? How can I tell if someone is addicted to a drug? How do we define addiction? This training seeks to increase the attendees overall knowledge of basic drug classes, the basic brain chemistry related to addiction, basic DSM-5 diagnostic criteria, and basic treatment modalities including ASAM levels of care.

- 1. Describe a basic overview of the history of drugs in society.
- 2. Discuss different drug classes and the characteristics of each class.
- 3. Understand basic brain chemistry and the effects drugs have on the brain.
- Review current DSM-5 TR diagnostic criteria and practical examples of each criteria.
- 5. Recall current ASAM criteria and levels of care and criteria for each level.

TRAINERS' BIOGRAPHIES

She has taught graduate level courses for Webster, Columbia College, Coastal Carolina and Webster University. She also is a contract clinical supervisor at the Dorchester A&D Commission. She has a wealth of experience with the more serious disorders as outlined in the DSM and has also served as Disaster Mental Health Lead for the local chapter of the American Red Cross for many years. She is also the immediate Past President of the SC Assn for Licensed Professional Counselors.

MARCH: Charissa Wolford, LISW-CP, LAC, CS, MAC is currently a Clinical Supervisor for the Phoenix Center in Greenville, South Carolina. As the owner of Helping Healers LLC – Charissa provides clinical supervision and various training opportunities. She is an alumna of the University of South Carolina where she received

a bachelor's degree in Experimental Psychology, a Master of Social Work degree, and a Certificate of Graduate study in Drug and Addiction Studies. Charissa has worked in the Alcohol and Drug Treatment field for over 15 years. She has worked previously with medication assisted treatment programs and other various populations including incarcerated youth and adults, and domestic violence survivors. Other notable work has included being a member of the SC Leadership Academy, which has been a South Carolina statewide initiative supported by DAODAS in efforts to produce a streamlined approach to Alcohol and Drug Treatment.
